### **APPLICATION and CERTIFICATION PACKAGE FOR OCCUPANCY**

Hidden Village is a manufactured housing co-op committed to low-income housing. Residents own their homes, and members run the 501(c)4 corporation that owns the community's common land and equipment.

The application to lease a lot is also an application to become a member of Hidden Village Owners Association. To be eligible for membership, you must meet income requirements, pass credit and background checks, own your own home as your primary and legal residence, have your application approved, and meet with representatives of the Board of Directors so we can get to know you and explain the responsibilities of membership. At that point, there is a one-time refundable membership fee of \$500, paid before moving in.

#### **APPLICATION PROCES - STEP 1**

1. Because a number of spaces are reserved for households with incomes at or below 50% of the Area Median Income (AMI), and others are limited to those below 80% of AMI, the first step in qualifying your income. Income limits for the last tax year are as follow:

	△ You will be provided with a form for a background and credit check for each occupant of your home age 18 and older, and will pay a non-refundable \$57 by money order to Hidde Village Owners Association for each adult occupant.						
	A copy of the Certificate of Title to the home showing you as the registered owner. If the purchase is occurring at the same time as your application for tenancy, you must be approved to move into the community <a href="PRIOR TO">PRIOR TO</a> finalizing the home purchase. In that						

- case, you will need to provide a copy of the Certificate of Title upon the home closing and your Purchase/Sale Agreement. Make sure the seller has a valid title, and that everyone listed on the title has signed for the sale.
- If you are installing a manufactured home, you must procure the required permits.

  Assistance on permits can be found by the seller or at Thurston County Planning

  Department. HVOA officers can help guide you in a general, non-professional way, but have no authority with the permit process.

#### **APPLICATION PROCESS - STEP 3**

If the background and credit checks qualify you and the other household occupants, we will contact you to set up a meeting with our Board, so we can explain how we operate, the rent, and other rights and responsibilities of membership. You will pay a \$500 refundable membership fee. This is most often collected at closing and forwarded to Hidden Village, at which point a Certificate of Membership will be issued.
